Goldenrod and Green Fields



I try to ignore it at first.

I notice the first yellow blossoms in August. I quickly look away. I look to the huckleberries, still green,

and bearing their delightful black fruit. The sassafras leaves reassure me; they are still green, and so are the glossy green leaves of the black oak.

Yet there I spy another, beside a thicket of bayberry and a bunch of switchgrass. Again I avert my gaze, yet the bright flowers of this plant – the goldenrod – cannot be ignored.

Goldenrod blossoms at the glorious end of summer. It begins to blossom just before summer's very zenith - the Agricultural Fair, the Oak Bluffs Fireworks, the Grand Illumination. Then September comes, and goldenrod bursts into bouquets of beauty, all while tropical storms sweep over the Island, and yellow school buses again rumble down South Road, and beetlebungs start turning scarlet.

Yet goldenrod also signals the fall and winter to come. And what's more, as September is such a time of change, whether of seasons or of school years, goldenrod marks the passage of seasons and of years. Admiring goldenrod in September is akin to reading A. Bartlett Giamatti's famous essay the "Green Fields of the Mind," about the end of the baseball season. "It breaks your heart. It is designed to break your heart," wrote Giamatti.

So goldenrod breaks my heart. It so cheerfully signals the unstoppable passage of time. Some years ago I wrote about goldenrod for the Sheriff's Meadow newsletter. I wrote of taking photographs on the first day of school, knowing that on that particular September day, all of our children stood there, lined up with their backpacks, but knowing that one day, the oldest one will be gone, and another day, the next, and then one day, all.

Last year that first day of days came. Our oldest child left for college. We bade her farewell to the drone of bagpipes on a beautiful September afternoon in Hyde Park. We left Chicago at dinnertime, drove through the night, and reached the ferry in Woods Hole in time for the 2:30 boat the next afternoon. Her life flashed through my mind as we drove. The tears came when we boarded the boat.

This year it is a bit easier. I find myself offering fatherly advice to my friends as I watch their children depart for Villanova or Lafayette or St. Andrew's or wherever they may be headed.

Today I again took our "back-to-school" photograph with our three younger children. They've grown. They line up with their backpacks. This year they smile dutifully. Even the dog poses.

With the dunes as a backdrop, the children smile. Beside them and behind them, along the dirt road and along the edge of the meadow, the goldenrod smiles upon the scene, too. Bright and yellow as a spring forsythia, the goldenrod marks the end of summer. It marks the approach of winter. And in its singular way, the goldenrod marks the march of the years, as unstoppable, unceasing, inexorable as the almighty sea, just beyond the distant dunes.

Walt Looney and Susannah Bristol were each re-elected to one-year terms as Treasurer and Assistant Treasurer, respectively, and Molly Glasgow was re-elected to a one-year term as Clerk.

The Board elected Patricia Favreau, Hillary Noyes-Keene and John Schaefer to a first, three-year term on the Board of Directors. Biographies of each new Director are included in this newsletter. Both Patty Favreau and Hillary Noyes-Keene are new to the Board, while John Schaefer returns after a one-year hiatus.

OK... its story time.

Benjamin Franklin said that in life there are only two certainties; death and taxes. He was mostly right.

Though the IRS may be intractable, only Father Time is truly undefeated – by some estimates he is about 100 billion and 0 versus the human race. Ted Williams' head notwithstanding, nobody has learned how to beat him yet. Clearly the most precious asset we are granted in our lives is the time we have to spend on this ball.

All of us here tonight have chosen to invest some portion of that asset in our Island. By the passage of time, (that is to say “as we age”) the finite nature of our lives becomes more obvious. As such, the obligation to protect our invested time – through support of SMF and the other entities that make the Vineyard our home – becomes not only clear and proper but natural and prudent. This is an appreciation which comes more easily to a head with a few gray hairs.

We are blessed on the Vineyard with an amazing diversity of talented and generous individuals willing to serve SMF such as the Event Committee and the six directors I just mentioned. As members cycle off of the board it is generally possible to replace their area of expertise whether it be design, legal, financial, environmental, educational, etc. It is not difficult to balance seasonal vs. year-round residents and aside from Aquinnah,

it is easy to maintain Island-wide representation. (By the way, to these ends, we keep a list and many of you are on it whether you know it or not). The most difficult variable to incorporate is youth. By nature, young people tend to have more on their plates – family obligations, budding careers with limited flexibility, residential uncertainty, etc. It is understandable that somebody with the hectic life of youth may not recognize the necessity to protect the investment of their time – its finite nature being not yet apparent.

Out of a Board retreat and Strategic Plan in 2010, SMF began an education program. Under the direction of Jennifer Blum and the Education Committee and through our Education Coordinator Samantha Look, it has taken off wildly. The program now brings children from each of the Island schools to several SMF preserves to partake in property specific curricula. This program is a great way to teach our children about

the flora and fauna of the island – essentially an outdoor biology class.

However, it can have a deeper impact if it can instill an appreciation of place and a germ of a sense of responsibility for the conservation and protection of that place. We can all help to insure the generational continuity of conservation by simply exposing our children and grandchildren to properties such as any of the SMF preserves. Exposure is 90% of the effort, because the properties will sing for themselves. The last 10% is a gentle note that if they wish to enjoy such places for the rest of their lives, they need to play a part.

Finally, my daughter Madeline graduated from the High School this spring and heads off to Scotland for college next month. I know that she has developed an appreciation of the Vineyard through SMF properties such as Sheriff's Meadow Sanctuary, Quansoo Farm, and Cedar Tree Neck. Whether she returns to the Vineyard – or finds some other corner of the world for which she can feel as we do about our island – I hope that she will continue the realization that we all need to conserve and protect that in which we have invested our most precious asset – our time.

Thank you all for your support – we look forward to another great year working together - enjoy the rest of the evening – Manga la port!

Feiner Real Estate Donates 10% of Commission to SMF

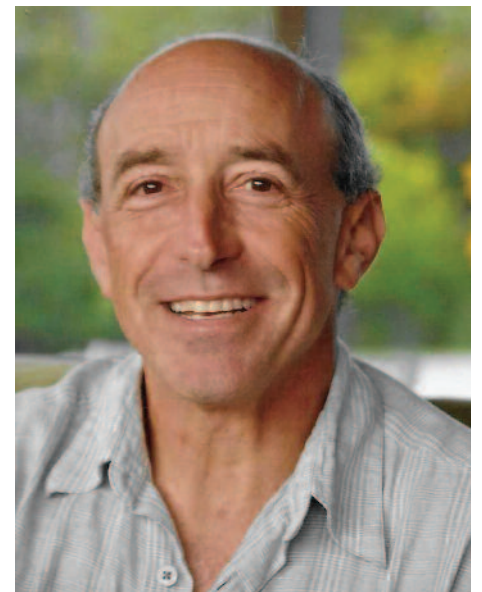
Island real estate broker Jim Feiner presented Sheriff's Meadow Foundation with a \$1,000 check in July, and announced a new charitable program that he has created.
